Both the UK Coaching Safeguarding and Protecting Children and the Time To Listen training must be renewed every three years by completion of an Online or Face to Face Refresher Course.

For renewal after 3 years, the Safeguarding and Protecting Children course is available as a shorter refresher course. The Time to Listen Course isn't available as a refresher and must be repeated.

NB – we cannot accept safeguarding training completed in another arena.

## **INTRODUCTORY**

Introductory training can be completed by anyone interested in furthering their knowledge of Safeguarding in Sport and can be used as a pre-curser to the Basic and Specialist Training.

As soon as possible upon starting and ideally annually, everyone should read these policies: Safeguarding Young People and Safeguarding Adults in Netball - <u>England Netball | Safeguarding Policies</u> and Diversity & Belonging - <u>England Netball | Diversity & Belonging</u> and similar club policies.

#### **BASIC LEVEL**

Basic courses are designed for those working in sport with regular responsibility for children and young people. This training should include the practical implications of raising awareness within a sports context, safeguarding legislation, identifying, responding, and reporting concerns and signposting for further information and sources of support. Basic Training is a pre-requisite to any specialist training completed thereafter.

## Safeguarding and Protecting Children Training - UK Coaching (3 hours)

## (not mandatory) Safeguarding and Protecting Children (16-18) UK Coaching (2 hours)

The course is created by specialists in child welfare and is written and delivered with the safety of the young coach in mind throughout. #### **SPECIALIST**

Specialist safeguarding training can only be completed after individuals have completed the Basic level training and is designed for individuals in roles with regular contact with under 18's and those with additional responsibilities such as designated safeguarding roles, such as Lead Safeguarding Officers and Club Welfare Officers; Those responsible for recruitment people to work with children; Case Management Groups and Event management roles. Specialist training addresses the specific needs of the roles concerned and delivery should include a face-to-face element.

#### UK Coaching 'Time to Listen Workshop' (3-4 hours)

This workshop will help you understand the role and responsibilities of a Welfare Officer and statutory agencies and what this means in practice. This workshop needs to be completed within three months of completing the Safeguarding and Protecting Children Course, and every 3 years thereafter **Time to Listen Workshop** <u>Welfare Officer Training: Time to Listen - UK Coaching</u> or <u>Learning - UK Coaching</u>

## What if I already have a Safeguarding Training Certificate from elsewhere?

We DO NOT accept external training in place of the required sport specific safeguarding training as outlined above. The training required by England Netball contains essential 'sporting context' which is not readily available from other providers. Due to the high numbers of external training providers, we are unable to assess each external course individually, in order to check its content.

In addition, any individuals leading netball activity in a community setting require an up-to-date England Netball DBS – apply for DBS and a Safeguarding and First Aid certificate – further information is available <u>here</u>.
